DEED - General Warranty

DORSET COUNTY, OKLAHOMA, DEED, 1908

THIS INDENTURE, Made this 29th day of October, A. D. 1908, between  
Eddie Bordery, a single man of lawful age  
 of Montgomery County, in the State of Oklahoma, of the first part and

John Jackson, of the second part.  
 WITNESSETH That said part g of the first part, in consideration of the sum of Two Hundred \$200.00 and 100 DOLLARS,  
 the receipt whereof is hereby acknowledged, does by these presents, Grant, Bargain, Sell and Convey unto said part g of the second part, his  
 heirs and assigns, all of the following described Real Estate, Situated in the County of Pulaski, and State of Oklahoma, to-wit:

The North West quarter of the South East quarter of Sec Twenty (20)  
Township Twenty (20) N Range Fourteen (14) E.  
The North West Ten (10) acres of Lot Two (2) Sec (17) Twp 13 Rge 27.  
The East half of South West qr of South West qr Sec 20 Twp 20 Rge 14.

TO HAVE AND TO HOLD THE SAME, Together with all and singular the Tenements, Hereditaments and Appurtenances thereunto belonging or in  
 anywise appertaining forever.

And said Eddie Bordery for his  
 heirs, executors or administrators, do hereby covenant, promise and agree to and with said part g of the second part that at the delivery of these  
 presents that he lawfully seized in his own right of and absolute and indefeasible estate of inheritance, in fee simple, of and in all  
 and singular, the above granted and described premises, with the appurtenances; that the same are free, clear, discharged and unincumbered of and from  
 all former and other Grants, Titles, Charges, Estates, Judgments, Taxes, Assessments, and Incumbrances, of what nature or kind soever;

and that he will warrant and forever defend the title to same unto said part g of the second part, his heirs and assigns, against said part g  
 of the first part, his heirs, and all and every person or persons, who may lawfully claim or to claim the same.
