

FOURTH: All of the powers and duties of the said W. A. Brownlee, Trustee, under said agreement are hereby abrogated and terminated, excepting only the duty of the Trustee to account for the proceeds from the sale of any oil which he may have received under said agreement and which may now be in his possession; and the said Trustee is authorized and empowered to pay said proceeds, if any, over to the said C. H. Stoddard, who, it is agreed, is entitled to the same.

FIFTH: All parties hereto hereby release the said Trustee of and from any and all liability on account of any of his acts as such Trustee under said agreement, excepting only the liability to account for and pay over the proceeds as aforesaid; and the said Trustee does hereby release any and all claims against all other parties to said agreement and against the said leasehold or the proceeds from the sale of the oil.
