and execute to said purchaser, J C. Birtcil the purchaser of said real estate and premises at said sale as aforesaid be immediately let into possession of said premises; and each and every part thereof, and the said defendants and each of them and every person who has come into possession of said premises, lands and tenements or any part of them, under said defendants or any of them, since the commencement of this action, shall upon the presentation of a copy of this order, or of the Sheriff's Deed for said premises, immediately deliver possession thereof to the said purchaser, and that upon refusal of said defendants or any of them, or anyone in possession of said premises, or any part thereof, to deliver immediate possession of said premises to the said purchaser J.
