FORM F. OSAGE MINING LEASE.

ASSIGNMENT OF GAS MINING LEASE.

WHEREAS, the Secretary of the Interior has heretofore approved a gas mining lease dated April 15, 1916, entered into by and between CHARLES OWEN, lessee, and the OSAGE TRIBE OF INDIANS, lessor, covering the following described land in the Osage Reservation, State of Oklahoma:

One hundred sixty-five thousand, seven hundred sixty (165,760) acres as shown by lease and records of the Department of the Interior, and the office of the Superintendent of Osage Tribe of Indians at Pawhuska, Oklahoma.

NOW, THEREFORE, for and in consideration of One (1.00) Dollar, the receipt of which is hereby acknowledged, the said CHARLES OWEN, the lessee in the above described lease, hereby bargains, sells, transfers and conveys all of his right, title and interest in and to the said lease, subject to the approval of the Secretary of the Interior, to OSAGE NATURAL GAS COMPANY.
