Smith, of Harris County, Texas, the patentee and owner and holder of certain formulas, processes and devices used in removing paraffine, and other foreign substances from oil wells, and of a number of amendments, supplements and improvements thereon, all of which are on file in the United States Patent Office in the City of Washington, D.
