ORDINANCE NO. 2499.

An Ordinance accepting and adding to the city of Tulsa, Oklahoma, a certain tract of land known as MELROSE SECOND ADDITION, to the City of Tulsa, Oklahoma, according to the recorded plat thereof, and declaring an emergency.

WHEREAS, a petition in writing has been presented to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, signed by over sixty (60%) percent of the property owners of the tract of land herein described and designated as MELROSE SECOND ADDITION, to the City of Tulsa, Oklahoma, said tract of land being in Tulsa County, Oklahoma, said tract of land being in Tulsa County, Oklahoma, said tract of land being in Tulsa County, Oklahoma and lying contiguous to and adjoining the present corporate limits of said City, which petition prays that said Board annex to said City of Tulsa, siad tract of land, and,

Beginning at a point, on the east line of and Six hundred and sixty (660) feet north of the southeast corner of Section Twenty-six (26), Township Twenty (20) North, Range Twelve (12) East; thence west along a straight line, parallel to and six hundred and sixty (660) feet north of the south line of said Section Twenty-six (26), a distance of six hundred and sixty (660) feet; thence north a distance of six hundred and sixty (660) feet; thence east a distance of six hundred and sixty (660) feet; thence south a distance of six hundred and sixty (660) feet to the point of beginning.
