SECTION 3. That an emergency exists for the preservation of the public welfare and safety, by reason whereof, this ordinance shall take effect from and after its passage, approval and publication.

ORDINANCE NO. 2577.

An Ordinance adding and annexing to the City of Tulsa, Oklahoma, a certain tract of land within Tulsa, County, Oklahoma, described as follows, to-wit: Beginning at a point on the West line of and seven hundred and three and seven-tenths (703.7) feet South of the Northwest corner of Section 8, Township 19-North, Range 13-3ast (said point being the intersection of the said West line of Section 8 and the Easterly line of the Missouri, Kansas, and Texas Railroad right of way); thence South-easterly along the said Easterly line of the Missouri, Kánsas and Texas Railroad right of way a distance of seven hundred and twenty-four and seventy-seven hundredths (724.77) feet; thence West along the South line of Lot 4, Block 3, of Fair Acres Addition to the City of Tulsa, Oklahoma, according to the duly recorded plat thereof, a distance of three hundred and seventy-eight and six-tenths (378.6) feet to the said West line of Section 6; thence North along the said West line of Section 8 a distance of Six hundred and seventeen (617) feet, more or less, to the point of beginning, and declaring an emergency.
