Witness, this agreement by and between R. E. Foreman, of Tulsa, Oklahoma, herein called the Trustee of the one part and J. M. Hartwell of Tuba, Oklahoma, and H. B. Gillett of Tulsa, Oklahoma, herein called subscribers of the other part, as follows, viz:

The said hamed Trustee and subscribers, of themselves, and for such other person of persons, who may hereafter become abscribers, have associated themselves together with the purpose of engaging in the Oil Business, generally including productions, Refining and Distribution and for such purposes have and so by these presents, mutually covenant and agree as follows; that is to say, the said named Trustee for himself as Trustee, covenants, declares and mutually agrees with the sadnamed subscribers, which agreement shall extend to and be binding upon all other persons, who may hereafter become subscribers, as follows, to-wit:

1. It is provided and agreed, that the tithe to all property, both real and personal, of every kind and character, whatsoever, that may now or hereafter belong to the Trust Estate hereby created, shall be taken and held by the Trustee and his successor or successors in the name of

of Tudsa, Oklahoma for the purposes, uses, trusts and upon the terms and conditions as hereinafter and hereinabove stipulated, it being further provided that, so far as possible, this Trust Estate shall be known and called the

"TULSA SERVICE OIL COMPANY",

of Tulsa, Oklahoma, by which name is shall contract, sue and be sued, take, hold and transfer all property and tracnact all business.

- 2. It is stipulated that the said named Trustee and his successor of successors shall have and exercise full and complete control and management of all of the assets and property of every kind and character, whatsoever, now or hereafter belonging to the Trust Estate hereby created, and shall conduct and carry on the bysiness of said Trust Estate in such manner, as in his judgement; he may deem proper and for the best interest of this Trust Estatemand, to this end, the said named Trustee and his successor or successors are further specifically authorized and empowered as follows, to-wit:
