AFFIDAVIT OF POSSESSION.

Sarah Rockwood, being first duly sworn, on oath, says that she is now a widow and has been for several years last past; that she is the present owner of the Northwest Quarter (NW $\frac{1}{4}$ ) of Section 10, Township 18 North and Range 12 East, Tulsa County, State of Oklahoma;

that she is at this time in actual, open, notorious and adverse possession of said premises; that the same are not now in possession of any renter thereon, or subject to any lease or leasehold estate for agricultural purposes, nor is anyone in possession of said premises or property at this time under any rental agreement or lease for agricultural purposes; nor are said premises subject to any oil or gas lease thereon save and except as to the S $\frac{1}{2}$  of said NW $\frac{1}{4}$  of Sec. 10, Twp. 18 N, R. 12E, which is held under rental payments according to the terms of a lease made to E. L.
