assigns; and whether such policy or policies have been actually assigned or not, they shall in case of loss be payable to the said nortgagee, its successors or assigns, to the extent of its its interest as mortgagee, its successors or assigns, in said premises; and that the said mortgagork or its successors or its assigns may assign all such insurance policies to any endorser of said note, or to any subsequent purchaser of said premises; and thatin the event of loss under such policy or policies, the said mortgagee or its successors or or assigns shall have and is hereby specifically given full power to settle or compromise claims thereunder and to demand, receive and receipt for all monies becoming payable there—under and to apply the alount so collected toward the payment of the indebtedness hereby secured, or in rebuilding or restoring the damages buildings or improvements, as the mort—gagee, its successors or assigns, may elect, without affecting the lien of this mrtgage for the full amount secured thereby before such damage by fire or tornado, or such payment over, tookplace.

rifth. To keep said premises free from all judgements, mechanids liens and all other statutory liens of whatsoever nature, to the end that the priority of these presents—may be at all times be maintained, and to pay to the mortgagee, its successors or assigns, within ten days, all sums, including costs, expense and reasonable agents and attorney after it may expend, or for which it may become obligated in any precedings, legal nor otherwise, to establish and sustain the lien of this mortgage, or its priority; or in defending against liens, claims, rights, estates, easements or restrictions of any person or persons asserting priority thereto; or for anabstract or extension of abstract of title to said premises; together always with interest on all, such sums at 10% per anum, from the date the same were paid; and for payment of said sums and interest, this mortgage shall stand as security furlike manner and effect as for payment of said debt.
