LEASE - GENERAL FORM.

This lease, made this 23rd day of August, 1924, by Joe Spaniard and Hepsy  
Spaniard, of the first part, to Joe Beasley, of the second part.

Witnesseth, that the said party of the first part, in consideration of the rents,  
covenants and agreements of the said party of the second part, hereinafter set forth, does  
by these presents demise, lease and rent to the said party of the second part, the following  
described property, situate in the County of Tulsa, State of Oklahoma, to-wit:

The southwest quarter of section 6, township 17, range  
14, the Hepsy McGilbra allotment, C-8019.

To have and to hold the same, unto the said party of the second part, from the first  
day of January, 1925, to the 31st day of December, 1925.

And said party of the second part, in consideration of the leasing the premises,  
as above set forth, covenant and agrees with the said party of the first part, to pay the  
said party of the first part his heirs or assigns, as rent for the same the total amount or  
sum of two hundred fifty and no/100 dollars, in two payments, as follows, to-wit:

One hundred twenty five dollars cash in hand paid the receipt of which is hereby  
acknowledged and balance \$125.00 as follows: First party agrees to let second party
