Installment Stock of said Association, in the sum of six & 67/100, (\$6.67) dollars, both interest and dues being payable on the 5th day of each and every month until sufficient assets accumulate to mature said shares and pay the holder thereof one hundred (\$100.00) dollars for each share, in accordance with the terms of the by-laws of the said Association; and in case of default in any payment of interest or dues, or any part thereof at the said stated times, or failure to comply with any of the conditions or agreements stated in the mortgage securing such payments, then this note shall immediately become due and payable, at the option of the legal holder hereof, and shall, after such default, bear ten per cent per annum, and if collected by suit, we, I, or either of us agree to pay an additional sum equal to ten per cent of the amount due, as attorney's fees.
