

one (\$1.00) dollar cash in hand paid, the receipt of which is hereby acknowledged, do hereby bargain, sell, grant, convey, transfer, assign, set over, relinquish and quit claim unto the said parties of the first part, their successors and assigns, all their right, title, claim and interest in and to that part of said lots two (2) and four (4) in section twenty five (25) township seventeen (17) range fourteen (14) east, lying above and outside of the meander lines along or near the south or west bank of the Arkansas River, as established and located by the United States Government Survey thereof, under and by virtue of the lease aforesaid now owned and held by them.
