- 3. The court further finds, from the evidence introduced in behalf of said petition that the same is fair and reasonable and that said deed should be approved.
- 4. It is therefore, order, adjudged and decreed by the court that said deed be and the same is hereby approved in accordance with an act of Congress passed and aproved May 27th, 1908, Public No. 140, as put in force by an act of Legislature of the State of Oklahoma, Approved 'April 2nd, 1915.
