repair the same with all reasonable speed and the rent shall not be required while the repairs are going on, but shall recommence and bepayable immedately after such repairs shall have been completed, but, if the premises shall be no injured by fire or otherwise as not to be rendered unfit for occupancy, then and in that case the rent ascerued or accuring shall not cease or determine and the sme shall be required by the lessor with reasonable promptness.

Sixteenth: It is further understood and agreed that said lesses, in the event all the agreements, covenants and terms hereof are faithfully kept and perfored by it, shall have the right to renew the lease for a firther term the reafter, upon a rental and terms to be mutually agreed upon by the parties hereto. In the event the parties hereto shall be unable to so agree upon the terms of said renewal, then the expiration of this lease, under the provisins, agreements and covenants hereof, said lesses will, without notice or demand, deliver said premises to said lessor, and hereby expressly waive any and all notice of what soever kind and character to quit and surrender said premises at such time or times, and if said lesses shall hold over or retain possession of the leases premises thereafter, with or without the consent of the lessor, in the absence of a formal agreement or extension, said lesses shall hold said premises merely from month to month, but nothing in this clause shall be misconstrued to permit the lesses to hold over beyond the term of the lease, against the will of the lessor.
