the estate consisted wholly of real estate known and described as follows , to-wit:

Lots one and two and the East one-half of Lot three

in Block 27, Skistock, Oklahoma,

And it further appearing that Mary T. Colgrove died intestate at Skiatook, Oklahoma, on the 27 day of June, 1922, and that she was at the time of her death a resident of Skiatook, Oklahoma, and that she left surviving her the following next of kin and heirs at law, and none others, to-wit: Richard Martin, her father, and Clyde C. Colgrove, her husband; that the property in her name at the time of her death was accumulated by her and her husband after their marriage and as a result of their joint efforts; and therefore the husband is entitled to the whole thereof at the as the surviying force, that the father, since her death, has deeded any interest he might otherwise have had to the said Clyde C. Colgrove.

And it further appearing that said estate is now in condition to be finally settled and distributed to the persons entitled thereto, and that the administration thereof should be brought to a close;

And it is further ordered that the said administrator be, and he is hereby fully and finally discharged from his trust as such administrator, and that his sureties theneforth be, and they are hereby, discharged from all liability for his future acts.
