TREASONERS ENDORSEMENT

MORTGAGE OF REAL ESTATE SUMPARED. THIS indenture made this 27th day of June A. D. 1924. between Anna C. Huntsman, and Lee L. Huntsman, wife and husband, Tulsa County, in the State of Oklahome, of the first part and W. P. Moore of Tulsa County, in the State of Oklahoma, of the Second part.

WITNESSETH. That said parties of the first part in consideration of Twenty Five Hundred Doblars, (\$2500.) the receipt of which is hereby acknowledged, do by those presents grant, bargain, , sell and convey unto said part --- of the second part his heirs and assigns, the following described Real Estate, situated in Tulsa County, and State of Oklahoma to-wit:

> Northwest quarter (NW $\frac{1}{4}$) of the Northeast quarter (NE $\frac{1}{4}$) of Section Twelve (12) Township Seventeen (17) North, Range Thirteen (13) East, containing 40 acres more or less according to the Government survey thereof,

TO Have and to HOLD THE SAME, unto the said party of the second part his heirs and assigns, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in any wise appertaining, forever.

PROVIDED, ADWAYS, And these presents are upon this express condition that where as said Anna C. Huntsman and Lee L. Huntsman have this day executed and delivered five certain promissory notes in writing to said party of the second part described as follows:

> One Note Dated June 27th 1924 for \$500. Ldue July 1st 1927 One Note Dated June 27th 1924 for \$500. due July 1st 1928 One Note Dated June 27th 1924 for \$500. due July 1st 1929 One Note Dated June 27th 1924 for \$500. due July 1st 1930 One Note Dated June 27th 1924 for \$500. due July 1st 1931 with interest at the rate of eight per cent per annum, and

payable semi- annually January 1st and July 1st of each year, should any inter est or principal not be paid when due it shall bear interest at the rate of 10% per amum until paid.

Now if said parties of the first part shall pay or cause to be paid to said party of the second part his hairs or assigns, said sum of money in the above described notes mentioned together with the interest thereon, according to the terms and tenor of the same, then this mortgage shall be wholly discharged and void; and otherwise shall remain in full force and effect. But if said sum or sums of money or any part thereof, or any interest thereon, is not paid when the same is due, and if the taxes and assessments of every nature which are or may be assessed and levied against said premises or any part thereof are not paid when same are by law made due and payable, the whole of said sum or sums, and interest thereon, shall then become due and payable and said party of the second part shall be entitled to possession of said premises . And said parties of the first part for said consideration do here by expressly waive an appraisement of said real estate and all benefit of the homestead exemption and stay laws of the state of Oklahoma
