SEWER KASEMENT

GOMPALLER,

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, the owner of the legal and equitable title to the following described real estate, situated in the City of Tulsa, Tulsa County, State of Oklahoma, for nd in consideration of the sum of One Dollar (\$1.00) cash in hand, paid by the City of Tulsa klahoma, and other good and valuable considerations, receipt of which are hereby acknowledged, do hereby grant and convey unto the said City of Tulsa, Oklahoma, a perpetual easement, through over, under and across the following described property, situated in said City to-wit:

A strip of ground, not to exceed ten (10) feet in width on either side of the center line of said sewer line, as shown by the blue prints on file in the City Engineer's office of the City of Tules, the center line of said Twenty (20) foot strip, being more particularly described as follows, to-wit:

> Beginning at a point on the South line of Lot 11, Glen Acres, a subdivision of the North One-half of the Southwest quarter of Section 8, Township 19-North, Range 13 -East, and a distance of 103 feet East of the Southwest comer of said Lot 11; thence in a Northerly direction on a straight line a distance of 422.1 feet to a point on the North line of said Lot 11, and a distance of 113.7 feet East of the Northwest corner thereof.

for the purpose of permitting the City of Tules to construct a sewer line thereto, through, over, under and across said property, together with all necessary and convenient appurtenances thereto; and to use and maintain the same, and of affording the City of Tulsa, its officers, agents, employees, and all persons under contract with it, the right to enter upon said premises and strip of land for the purpose of surveying, excavating for, laying, constructing, operating, repairing, relaying and maintaining said sewer line and for the further pum ose of enabling the City of Tulsa, to do any and all necessary and convenient things, incident to such construction, operation, repairing, and maintaining of such sewer line.

TO HAVE AND TO HOLD such easement and right of way unto the City of Tulsa, its successors or assigns, forever.
