That the undersigned, the owner of the legal and equitable title to the following described real estate, situated in the City of Tulsa, Tulsa County, State of Oklahoma, for end in consideration of the sum of One Dollar (\$1.00) cash in hand paid by the City of Tulsa , Oklahoma, and other good and valuable considerations, receipt of which are hereby ack nowledged, do hereby grant and convey unto the said City of Bulse, Oklahoma, a perpetual easement, through, over, under and across the following described property, situated in said City,

A strip of ground, not to exceed ten (10) feet in width on either side of the center line of said Sewer line, as shown by the blue prints on file in the City Engineer's office of the City of Tulsa, the center line of said Twenty (20) foot strip, being more particularly described as follows, to-wit:

> Beginning at a point 20 ft East of the NW cor of Lot 2 Blk 178 0. T. Thence South a Distance of 90 ft all in The City of Tulsa, Okla.
