Twenty (20) North, Range Thirteen (13) East, Tulsa County, Oklahoma; thence south Forty-four (44) feet; thence eastwardly along a line which lies Forty-four (44) feet southwardly of, normally distant from and parallel with the north line of said Northeast (NE) quarter, of Southeast (SE) quarter of Section Thirty-one (31) a distance of five hundred fifty-two and six-tenths (552.6) feet to a point of a curved line, last above described line being tangent thereto; thence continue Northeasterly along a curved line concave to the left and having a radius of Six Hundred twenty-five and eight-tenths (625.8) feet to an intersection with the North line of said Northeast (NE) quarter of the Southeast (SE) quarter of Section Thirty-one (31), Township Twenty (20) North, Range Thirteen (13) East; thence westerly along said line approximately seven hundred eighty-three (783) feet to the place of beginning. Containing Sixty-nine hundredths (0.69) of one acre of land, more or less.
