searching for, drilling wells, sinking shafts, mining, digging, extracting, taking and carrying away all of the oil, gas, coal and other minerals in or under said lands, or that may be found therein or thereunder, and also the right to possession and use of so much of said premises at all times as may be necessary to the practical carrying out of the purposes and provisions of this grant.

It is hereby expressly declared that whereas the land, particularly described in this conveyance is understood to be subject to an oil and gas mining lease in favor of No One. so as to pass to, and rest in said S. M. Byers, E. M. Byers, and J. T. Harley a one half interest not only in the oil and gas, but also all rents and royalties there in reserved to the lessor.

And it is hereby further expressly declared that it is the true intent and purpose of this conveyance to pass to and vest in the said S. M. Byers, E. M. Byers, and J. T. Harley an undivided one half interest in all the mineral and mineral rights in the land first described herein, or that at any time may be found therein or thereunder, and all grantor;s rights to operate for said minerals, and deal and contract with regard thereto, including the leasing thereof, as fully to all intent and purposes as if the said S. M. Byers, E. M. Byers, and J. T. Harley was the absolute owner of the entire title and estate in said lands.
