All of Lots 1,2,3,4,7,8,9, in Block Six, and all of Lot 1 in Block Seven, of Lawnwood Addition to the City of Alsa, County of Tulsa, State of Oklahoma, according to the recorded plat thereof,

All located in Section Eight (8), Township Nineteen (19) North, Range Twelve (12) East.

It is agreed that this lease shall remain in force for a term of twelve months from this date, and as long thereafter as oil or gas, or either of them is produced from said land by the lesses.

In consideration of the premises the said lessee covenants and agrees: To deliver to the credit of lessor free of cost in the pipe line to which he may connect his wells, the equal to one-eighth part of all oil produced and saved from the leased premises. To pay the lessor the equal to oneseighth part, each year, for the gas from

each well where gas only is found, while the same is being used off the premises.

To pay lessor for gas produced from any cil well and used off the premises or for the manufacture of casing-head gas the equal to one-eighth part per year, for the time during which such gas shall be used, said payments to be made annually.

If no well be commenced on said land on or before One month after approval of abstracts, this lease shall terminate as to both parties.

Should the first well drilled on the above described land be a dry hole, then and in that event, if a second well is not commenced on said land within twelve months, this lease shall terminate as to both parties.

If said lessor owns a less interest in the above described land than the entire and undivided fee simple estate therein , then the royalties herein provided shall be paid the lessor only in the proportion which his interest bears to the whole and undivided fee.

Lessee shall have the right to yee, free of cast, gas, oil and water produced on said land for its operation thereon, except water from wells of lessor.

When requested by lessor, lessee shall bury its pipe lines below plow depth. No well shall be drilled nearer than fifty (50) feet to the house or barn now on said premises, without the written consent of the lessor.

Lessee shall pay for damages caused by its operations to growing drops on suid land.

Lessee shell have the right at any time to remove all machinery and fix wures placed on said premises, including the right to draw and remove casing.

Lessor hereby agrees and warrants to defend the title to the lands here in described , and agrees that the lessee shall have the right at any time to redeem for lessor, by payment, any mortgages taxes or other liens on the above described lands, in the event of default of payment of lessor, and be subrogated to the rights of the holder thereof.

It is understood and agreed, that whereas, the lessors own different portions of the acreage hereby leased, that if oil or gas is found upon any portion of the leased premises then the respective lessors shall share in the royalty hereby reserved, in the proportion that
