KNOW ALL MEN BY THESE PRESENTS: That for and in consideration of One Hundred Dollars, (\$100.00) and other good and valuable considerations this day in hand paid to TULSA LIGHT AND POWER COMPANY, an Oklahoma corporation, hereinafter referred to as First Party, by PUBLIC SERVICE COMPANY OF OKLAHOMA, an Oklahoma corporation, hereinafter referred to as Second Party, the receipt of which payment is hereby acknowledged, First Party HAS SOLD and by these presents does hereby SELL, ASSIGN, TRANSFER, and SET OVER unto Second Party and its successors and assigns all of the electric plant and distribution system, rights, privileges, (except certain franchises hereinafter provided to be expressly excluded), and properties of every sort, real, personal, and mixed, tangible and intangible, sold and delivered to First Party September 15, 1924, by Martin J. Insull of Chicago, Illinois, as evidenced by the written assignment of Martin J. Insull of said date, being those by said Martin J. Insull purchased August 11, 1924, by a certain contract of sale and purchase that day executed by Sand Springs Home, Sand Springs Railway Company, and Sand Springs Power, Light and Water Company, all being Oklahoma corporations, and Charles Page, of Sand Springs, Oklahoma, on the one hand, and Martin J. Insull on the other hand, being among other things, the entire electric plant and distribution system, business, and good will, of Sand Springs Home, an Oklahoma corporation, located within certain territory in Tulsa County, Oklahoma, more particularly described as follows:

All of the City of Tulsa and West Tulsa, Oklahoma, and all adjacent subdivisions of each; also all territory south of the Arkansas River between West Tulsa and the point where Sand Springs Power Line crosses Arkansas River near Price, Oklahoma; but not including any territory lying west of the City limits of Tulsa and between the Osage boundary and the Arkansas River;

And also the every property, right, privilege, and enjoyment of Tulsa Light and Power Company as successor of Martin J. Insull under the said contract of August 11, 1924, including all undistributed net earnings of said properties since August 1, 1924, and all additions to said properties made since that date;
