

## A F F I D A V I T

T. E. Smiley of lawful age, being first duly sworn on his oath, says: that he is now and has been continuously, for more than twenty years last past, a resident of the City of Tulsa, Tulsa County, Oklahoma.

That he is now and has been ever since its being platted and dedicated, personally acquainted with Fairview Addition to said city and with Lot Six (6) Block Seven (7) in said addition and has personal knowledge that in a certain deed executed by Tulsa Clock and Watch Company, to one, F.E. Turner on the first day of September, 1905 and recorded in Book A at page 721 of the records of Tulsa County, Oklahoma and originally filed for record at Claremore Indian Territory and recorded in Book 11 at page 624 thereof, it was the intention of said grantor to convey said Lot 6 in Block 7 in said Fairview Addition and that the words "Fairview Suburb" appearing in said deed was a mistake of the scrivener and was intended by said grantor to be Fairview Addition.

That afterward and on the 19th day of May, 1914, said identical Lot was, by said F.E. Turner conveyed to affiant, as trustee which said deed was filed for record and recorded in Book 157 at page 456 of the records in the office of the Register of Deeds of said Tulsa County; and that lot 6 in Block 7, Fairview Suburb to Tulsa, Indian Territory and Lot 6, Block 7, Fairview Addition, to the City of Tulsa, Tulsa County, Oklahoma, is one and the same identical tract of land.

Affiant further states that at the date of the execution of the said deed from said F. E. Turner to affiant as trustee, and said premises therein described, nor any part thereof were not and never had been the homestead of said F.E. Turner.
