SHERIFF'S DEED.

THIS INDENTURE made this 3rd day of March, A.D. 1925, by and between R. D. Sanford, as sheriff of Tulsa County, State of Oklahoma, of the first part, and Jno. M. Goldesberry, as trustee of the use and benefit of Tulsa County, State aforesaid of the second part.

WITNESSETH:

WHEREAS, by virtue of a general execution and order of sale, issued out the office of the Court Clerk, within and for Tulsa County, State aforesaid, properly attested, sealed and dated the 9th day of January, 1925, upon a certain judgment in cause number 25687, pending in said District Court, wherein the State of Oklahoma, upon the relation of Jno.
