RIGHT OF WAY CONTRACT

Handlin a single man hereafter called grantors, hereby grant unto Sinclair Pipe line Company, A Maine corporation, hereafter called grantee, the right to lay, maintain, inspect operate, replace, change or remove a pipe line for the transporation of oil or gas and also the right to erect, install, maintain inspect, operate and remove telegraph and telephone lines and the equipment and apparatus therefor, if grantee desires to do so, to be used in connection with any pipe line hereafter constructed by said grantee on, over and through the following described land of which grantors warrant they are the owners in fee simple, situated in Tulsa County, State of Okla., towit: NE4 of NE 4 section 36, Township 21N, Range 12E, N2 SE4 of NE4 Section 36, Township 21N, Range 12E together with the right of ingress and egree to and from said land for any and all purposes necessary and incident to the exercise by said grantee of the rights granted by this contract.

Grantors reserve the right to use said land for any and all purposes except the purposes hereby granted to said grantee.
