DEED-GENERAL WARRANTY.

INTERNAL REVENUE

THIS INDENTURE made this 17th day of April A.D.1917, between ~~Mary E. Lively~~ ^{Cancelled} Mary E. Lively, a widow woman and Hettie Drake and Hattie Coonrod of Collinsville, Rogers County, Oklahoma, parties of the first part, and P. H. Lively of Ardmore, Oklahoma party of the second part.

WITNESSETH, That for and in consideration of the sum of Six hundred & 00/100 and other good and valuable considerations) - - Dollars (\$600.00) receipt of which is hereby acknowledged, parties of the first part do by these presents grant, bargain, sell and convey unto the said party of the second part, his heirs and assigns, all of the following described real estate, located and situated in the County of Rogers, State of Oklahoma; to-wit:

All of Lots Numbered Seven and Eight (7 & 8) in Block Numbered Four (4) in Highland Park Addition to the town of Collinsville, Rogers County, Oklahoma, according to the official and recorded plat thereof, together with all the improvements thereon and the appurtenances thereunto belonging, and warrant the title to the same, but is expressly covenanted and agreed by the grantee herein, his heirs, successors and assigns, that as a part of the consideration of this deed and conveyance, that this deed and conveyance is made subject to the following conditions and restrictions, to-wit:

First: That said grantee, his heirs, successors or assigns shall not erect on said lot a residence or other building within twenty-five (25) feet of the front street boundary line of said lot.

Second: That said grantee, his heirs, successors or assigns shall not sell or convey said lot, or any part thereof, to any person of African descent.

Third: That if any residence or other building shall be erected on said lot within said twenty-five (25) feet of the front street boundary line of said lot, or if said lot be sold or conveyed to any person of African descent by said grantee herein, his heirs,
