CONTRACT.

This contract made and entered into by and between R. R. Park of Tulsa, Oklahoma party of the first part and L. C. Harbert of Tulsa party of the second part witnesseth:

That first party agrees to sell to second party and second party agrees to purchase from first party the following described property to-wit:
