ORDINANCE NO. 2777

An Ordinance adding and annexing to the City of Tulsa, Oklahoma, a certain tract of land within Tulsa county, Oklahoma, described as follows, to-wit: Lots 1 2 and 3, of Block 3; and Lots 1, 2, 3 and 6, of Block 10, Fair Acres Addition to the city of Tulsa, Oklahoma; and all of City of Tulsa, Oklahoma, according to the duly recorded plats thereof, and declaring an emergency.

WHEREAS, it has been made to appear to the Mayor and Board of Commissioners of the City of Tulsa, Oklahoma, that the hereinafter described tract of land, situated in Tulsa, Tulsa County, Oklahoma, lies contiguous to and adjoins the present, corporate limits of the City of Tulsa, Oklahoma, on three or more sides.

WHEREAS, it further appears to the Mayor and Board of Commissioners of said city that the said tract of land hereinafter described abuts said city on three or more sides and should be annexed to the City of Tulsa and entered within its corporate limits and that said tract of land does not exceed forty acres.

NOW THEREFORE BE IT ORDAINED BY THE MAYOR AND BOARD OF COMMISSIONERS OF THE CITY OF TULSA, OKLAHOMA.

SECTION 1. That a tract of land abutting on three sides with the corporate limits of the City of Tulsa, Oklahoma, situated in Tulsa county, Oklahoma, more particularly described as follows, to-wit:

Beginning at a point on the west line of Section 8, Township 19 North, Range 13 East, said point being a distance of 495.45 feet north of the Southwest corner of the Northwest Quarter of Section 8, Township 19 North, Range 13 East; thence east, along a line parallel to the East and West Quarter Section line a distance of 330 feet to a point, said point being the Southeast corner of Lot 1, City View Hill Second Addition; thence north, along a line parallel to the North and South Quarter Section line a distance of 165.15 feet to a point, said point being the Southwest corner of Lot 2, Block 10, Fair Acres Addition; thence east, along a line parallel to the East and West Quarter Section line, a distance of 282 feet to a point, said point being the Southeast corner of Lot 2, Block 10, Fair Acres Addition thence southeasterly a distance of 387.6 feet to a point, said point being the intersection of the center line of Fourteenth Place and the Westerly line of the M.K.T. Right of Way; thence east along a line parallel to the East and West Quarter Section line to a point, said point being 330.3 feet north of and 1,650 feet west of the center of Section 8, Township 19 North, Range 13 East; thence north along a line parallel to the North and South Quarter Section line, a distance of 990.9 feet to a point, said point being the intersection of the center line of Atlanta Place and Thirteenth Street; thence west, along the south line of the Northwest Quarter of the Northwest Quarter of Section 8, Township 19 North, Range 13 East, a distance of 990 feet to the intersection of said Quarter Section line with the west line of Section 8, Township 19 North, Range 13 East; thence south along said Section line a distance of 825.75 feet to the point of beginning.

be and the same is hereby added to and annexed to the said City of Tulsa, Oklahoma, and the corporate limits of said city be and the same hereby are extended to include said tract of land for all purposes.

SECTION 2. That the City of Tulsa, Oklahoma, hereby retains and reserves a perpetual
