GENERAL WARRANTY DEED

THIS INDENTURE. Made this 25th day of June, 1924, between OKLAHOMA UNION RAILWAY COMPANY, A Corporation, Party of the FirstPart and THE CITY OF TULSA, OKLAHOMA, A Municipal Corporation, Party of the Second Part

WITNESSETH: That in consideration of the sum of One (\$1.00) Dollar, the receipt of which is hereby acknowledged, said party of the First Part does, by these presents, grant, bargain, sell and convey unto said Party of the Second Part, its heirs and assigns all of the following described real estate, situated in the County of Tulsa, State of Oklahoma, to-wit:

All that part of Lot Eight (8), in Block Forty-two (42) Owen Addition to

the City of Tulsa, Oklahoma, lying South and East of the following described

line to-wit:

Beginning at a point in the South line of said Lot Eight (8) which is Forty-one and six-tenths (41.6) feet, more or less, West from the Southeast corner thereof; thence North-easterly and on a straight line, to a point in the East line of said Lot Eight (8), which is Eighty-two and Eight-tenths (82.8) feet, more or less, North from the Southeast corner thereof

All that part of Lot Seven (7) and Eight (8), in Block Ninety Five (95) Original Town of Tulsa, Oklahoma, lying within the following described lines, to-wit:
