A part of Lot Seven (7) in Block One Hundred thirty-six (136) of the original townsite of Tulsa Oklahoma, according to the recorded plat thereof, and more particularly described as follows, to-wit:

Subdivision Number One (1) of Lot Number Seven (7) in Block One Hundred Thirty-six (136), according to duly recorded plat of said Lot and the official plat of said City of Tulsa, Oklahoma, now on file in the office of the County Clerk, Tulsa County, Oklahoma, and more particularly described as follows: Beginning at the Northwestern corner of said Lot 7 and extending in an Easterly direction along the Northerly line of said lot a distance of 90 feet; thence in a Southerly direction and at right angles to the Northerly line of said Lot 7 a distance of 50 feet; thence Westerly and parallel to the Northerly line of said Lot 7 a distance of 90 feet to the intersection of the Westerly line of said Lot 7 and Main street; thence Northerly along the Westerly boundary line of said Lot 7 a distance of 50 feet to the Northwestern corner of said Lot 7, the place of beginning;

Subdivision Number Two (2) of Lot number Seven (7) in Block One Hundred Thirty-six (136) according to the duly recorded plat of said lot and the official plat of said City of Tulsa, Oklahoma, now on file in the office of the County Clerk, Tulsa County, Oklahoma, and more particularly described as follows: Beginning at a point in the Southerly line of said Lot 7, 50 feet South of the Northwestern corner thereof; running thence in a Southerly direction a distance of 50 feet to the Southwesterly corner of said Lot 7; thence in an Easterly direction along the Southerly side of said Lot 7 and at right angles with the Westerly side of said Lot 7 a distance of 90 feet; thence in a Northerly direction at right angles with the Southerly side of said Lot 7 and parallel with the Westerly side of said Lot 7 a distance of 50 feet; thence in a Westerly direction parallel with the Southerly side of said Lot 7 a distance of 90 feet to the place of beginning;
