NOW, THEREFORE, For and in consideration of One Dollar (and other good and valuable considerations), the receipt of which is hereby acknowledged, the undersigned, the present owner of the said lease and all rights thereunder or incident thereto, do hereby bargain, sell, transfer, assign and convey unto The National Drilling Company an undivided one fourth (1/4) interest of his entire interest in said oil and gas lease of his right, title and interest of the original lessee and present owner in and to said lease and rights thereunder insofar as it covers the above described property together with all personal property used or obtained in connection therewith to The National Drilling Company and its heirs, successors and assigns.
