Williams, otherwise known as L. T. Williams, George D. Hope Lumber Company, a corporation, Parker-Gordon Cigar Company, a corporation; H. E. Ketcham, Ben.Moskowitz, M. S. Wasserman, M_Otor Tire & Supply Company, a corporation, Martha Jones, and Dickinson-Reed-Randerson Company, a corporation; and

WHEREAS, said decree of foreclosure directed the sheriff of Tules County, Oklahoma to advertise and sell said property with appraisement for the purpose of obtaining funds with which to pay said judgment and decree; and,

WHEREAS, an order of sale was issued on the 30th day of June, 1924, by the Clerk of said court upon a written praccipe filed by the plaintiff, directing the sheriff to sell said property with appraisement; and .
