Now, Therefore, For and in consideration of One Dollar, ( and other good and valuable considerations), the receipt of which is hereby acknowledged, the undersigned, the present owner of the said lease and all rights thereunder or incident thereto, does hereby bargain, sell, transfer, assign and convey unto H. R. Fabyan all of his right, title and interest of the original lease and present owner in and to the said lease and rights thereunder in so far as it covers the undivided one (1/64) sixty fourth of the East one half of the NW 1/4 of the NE 1/4 and the West one half of the NE 1/4 of the NE 1/4 of Section No. 1, Township 17 North, Range 14 East, containing 40 acres, together with all personal property used or obtained in connection therewith to H. R. Fabyan and his heirs, successors and assigns.

And for the same consideration, the undersigned for himself and his heirs, successors and representatives, does covenant with the said assignees, his heirs, successors or assigns, that he is the lawful owner of the said lease and rights and interests thereunder and of the personal property thereon or used in connection therewith; that the undersigned has good right and authority to sell and convey the same, and that said rights, interest and property are free and clear from all liens and encumbrances, and that all rentals and royalties due and payable thereunder have been duly paid.
