## RELEASE OF MORTGAGE.

KNOW ALL MEN BY THESE PRESENTS, That the Farm and Home Savings and Loan Association of Missouri, a corporation organized and doing business under the laws of Missouri, at the City of Nevada, in said State, for and in consideration of One Dollar, and for other valuable considerations, the receipt of which is hereby acknowledged, do hereby remise, release, convey, satisfy, discharge and quit claim unto Oklahoma Steel Castings Company, a Corporation of Tulsa County, Oklahoma all the right, title, interest, claim or demand whatsoever, it may have acquired in, through or by a certain mortgage bearing date of April 19th, 1924 and recorded in the office of Register of Deeds in and for Tulsa County, Oklahoma, in Book No. 527 at page No. 37 to the premises herein described, as follows: All of the North Fifty (50) feet of the following described real estate; Beginning at a point 1146.67 feet North of the Southeast corner of the Northeast quarter of Section 36, Township 20 North, Range 12 East, said point being on the range line between Ranges 12 and 13; Thence due South 481.57 feet to a point on said range line where it intersects with the North right-of-way line of the Tulsa and Santa Fe Railroad; thence North 72 degrees and 8 minutes West along said right-of-way line a distance of 311.31 feet to a point of curve; thence running westerly along a line curving to the left, said curve having a radius of 633.8 feet a distance of 334.0 feet to a point of tangent; thence South 77 degrees and 39 minutes West a distance of 349.22 feet to a point; thence South 75 degrees and 57 minutes West a distance of 68.22 feet to a point of intersection with the right-of-way of the main line of the Atchison, Topeka and Santa Fe Railroad; thence North 47 degrees and 16 minutes East along the East right-of-way line of the Atchison, Topeka and Santa Fe Railroad a distance of 94.2 feet to a point; thence North 17 degrees and 29 minutes West along the said right-of-way line a distance of 11.4 feet; thence North 48 degrees and 42 minutes East along the said right-of-way line a distance of 579.0 feet to a point; thence East 519.4 feet to the point of beginning, and all improvements thereon, it being hereby specifically agreed and understood that the said mortgage remains in full force and effect as to the remaining property described in said mortgage, and this release is made for the purpose of releasing only that portion of said property, in said mortgage, as is described above, together with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining.
