The Southwest quarter of Section 17, Township 19 North, Hange 12 East, and that the said Mary Kelly, deceased, died on or about the ---- day of -----, 1901, and that the said Reuben Kelly, deceased, died on or about the ----- day of -----, 1903; that both of them died intestate; the petitioner further states that both of the deceased were residents of what is now Tulsa County, Oklahome, at the date of their deaths and that there has been no issue born to them since the 4th day of March, 1906.

The petitioner further states that on the 29th day of Sept., 1908, as one of the heirs at law of the said Mary Kelly, deceased, and Reuben Kelly, deceased, she made, executed and delivered to one Charles Page, and A. F. Ault, a deed of conveyance, whereby she conveyed her interest in the lands above described to the said Charles Page and A. F. Ault, in consideration of the sum of \$1,000.00, which said consideration is adequate and which said deed is herewith submitted for the approval of this Court.

WHEREFORE, the petitioner prays for an order approving said deed.
