Townsend caused said tract of land to be laid out in lots and blocks, to be known as Northmoreland Addition to the City of Tulsa Oklahoma,

That he has continued to be well acquainted with said tract of land up to this date, that he is particularly well acquainted with lot nine block two, which said lot faces Pine Street and lies 200 feet east of Cincinnati Ave the same being the west line of the said section 36, Town 20 Range 12 E.
