come from this trust in convenient in stalments, at least quarterly, during his lifetime. Provided, however, that upon the death of my said son leaving surviving him any child or children, then this trust estate, including principal and whatever accumulations there may be in the hands of my said Trustee at such time, shall be immediately paid, transferred and delivered to such surviving child or children of my said son equally, share and share alike, or to the legally appointed guardian for the use and benefit of any such surviving child or children who are minors,

Provided further, That upon the death of my said son without leaving surviving him

any child or children, then one-half of this trust estate, including principal and whatever accumulations there may be in the hands of my said Trustee at such time, shall be immediately paid, transferred and delivered to my daughter, Bertha Ewell, without any restrictions or limitations whatsoever. Provided, that if my said daughter be not living at such time, then the one-half portion of this trust estate herein given and bequeathed unto her shall be held in trust for the use and benefit of my grandson, Carl Ewell, who is the son of my said daughter, and the net income from this one-half portion of the trust estate, or so much thereof as may be necessary or advisable in the judgment of my said Trustee, shall be expended for the maintenance, education and support of my said grandson until he shall attain the age of twenty-one years, after which time my said Trustee shall pay to my said grandson the entire net income from the portion of the trust estate held for his use and benefit until he shall attain the age of twenty-five years, at which time my said Trustee shall pay, transfer and deliver to him one-half of the portion of the trust estate, including both principal and accumulations, so held for his use and benefit, and the remainder of such portion shall he held in trust by my said Trustee endthe net income therefrom paid to him in convenient instalments, at least quarterly, until my said grandson shall attain the age of thirty years, and when my said grandson shall attain the age of thirty years I hereby direct that my said Trustee shall pay, transfer and deliver to him all of the trust estate then in its hands for his use and benefit, the same to be his without any further restructions or limitations whatsoever. Provided, that should there be any surplus net income at any time before my said grundson shall attain the age of twenty-one years, over and above that necessary or advisable to be expended for his maintenance, education and support, then my said frustee shall invest such surpluse from time to time and the same shall become a part of the principal of the portion of the trust estate held for his use and benefit and shall be disposed of as herein provided. Provihed further, that in case of the death of my said grandson before receiving all of the portion of the trust estate herein directed to be held for his use and benefit, then such portion so remeining in the hands of my said "Trustee at the time of his death shall be divided and disributed among his heirs at law determined by the laws of descent and distribution in force and effect in the State of Oklahoma at the time of the death of my said grandson.

Provided further, that upon the death of my said son. Charles M. Crossland, without leaving surviving him any child or children, the remaining one-half of this trust estate shall be divided equally and disposed of as follows: One-half of such remaining portion of the trust estate shall be immediately paid, transferred and delivered to the Grand Lodge of the Independent Order of Odd Fellows of the jurisdiction of the State of Oklahoma for the express purpose of the maintenance of and the livings in the Independent Order of Odd Fellows' Home at Checoteh, Oklehome, or at any other place in the Eastern part of the State of Oxlahoma to which said Home may be removed or at which it may be located; and the other onehalf of such remaining portion of the trust estate shall be immediately paid; transferred and delivered to The Salvation Army, a religious and charitable corporation in the United States of America, the headquarters for the Central Territory being located at 108 North Dearborn
