This is to certify that I, L. J. P. Rooney, a surveyor, of Tulsa, Oklahoma, have carefully and accurately surveyed and staked Mountain View Addition, an addition to the City of Tulsa, in Tulsa County, Oklahoma, and that the same is an amendment to and a re-dedication of, certain lots in Davis-Wilson Heights, an addition to the City of Tulsa, in Tulsa County, Oklahoma, the said lots so re-platted being in the former plat of Davis-Wilson Heights described as follows:

Lots 2,3,4,5,6 and 7, in Block 3 of Davis-Wilson Heights; Lots 2,3,4,5, and 6 in Block 4 in Davis-Wilson Heights;

said lands so re-platted are as acreage, including the streets and alleys described as follows:
