Agreement

THIS AGREEMENT, Entered into this 9th day of September, 1924, by and between Wm. P. Merrell, of Claremore, Okla., party of the first part and A. F. Chamberlin of Vinita, Okla., party of the second part.

WITNESSETH: That for and in consideration of the sum of Ten and No/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged, the party of the first part does, by these presents, demise, lease and let unto the second party for agricultural purposes the following described land, situated in Tulsa County, Oklahoma, to-wit:

West Half of Northeast Quarter of Northwest Quarter and Northeast Quarter of Northeast Quarter of Northwest Quarter of Section 27, Township 21 North, Range 13 East - - - -

It is further understood that second party shall have the right to remove any and all buildings or fences which he may erect at the expiration of this lease.

TO HAVE AND TO HOLD said described premises to the second party, his heirs and assigns, for the term of One Year from January 1, 1925.
