Agreement Supplemental to Mortgage.

This agreement entered into this 30th day of August, 1924, by and between Ida M. Robinson and Elmer R. Wells as a supplemental part of a certain mortgage which was given by the said Elmer R. Wells to Ida M. Robinson on

Said mortgage dated the 15th day of June, 1922, and running for a period of five (5) years from said date, with a consideration of Fifteen Hundred (\$1500.00) Dollars at ten (10) per cent. It is subsequently agreed by and between the said Ida M. Robinson and Elmer R. Wells that for the consideration of One (\$1.00) Dollar in hand paid; said Ida M. Robinson agrees to reduce the interest rate of said \$1500.00 mortgage to eight (8) per cent per annum, payable monthly or semi-annually and to accept part or full payment of the principal at any time before the expiration of the five-year period should the mortgagee or his assigns desire to make payment or part payment of principal before the expiration date of said mortgage.
