piration of this lease, or for a reasonable time thereafter.

That the lessees promise and agree to pay as rental for said premises the sum of Fifty Dollars per month, payable on the first day of each and every month, and that in event of failure to pay said rental after a reasonable notice of default, the lessors shall have the right to declare the lease terminated, and thereupon the lesses shall have no further rights hereunder, except to remove their property therefrom.

It is expressly agreed that, whereas the lessees contemplate to emply Jno. E. Clond. one of the lessors, to manage a filling station upon said premises, from month to month, now therefore, in event of such employment, then during the time of such employment the lessees shall, in lieu of the rent above provided for, pay to the said lessors a sum equal to ten per cent of the net profits realized from sales made in the course of the filling station business conducted upon said premises.

This agreement shall bind and run in favor of the parties hereto, their heirs and assigns.
