The said party of the first part, for himself, his heirs, representatives and aseigns, hereby expressly agrees that in case of foreclosure of this mortgage as here inbefore provided , he will pay to the plaintiff or other party foreclosing this mortgage, a reasonable attorney fee, therefor; such fee to be due and payable upon the filing of petitionfor forecloeure, and the same shall be a further charge and lien upon the premises described in this mortgage, and the amount thereof shall be recovered in said foreclosure suit and included in the judgment rendered in such action, and shall be enforced and collected in the same manner as the principal debt secured thereby.
