KNOW ALL MEN BY THESE PRESENTS:

That Whereas, Jennie May Cook and John R. Cook, husband and wife, are the owners of

East Half (E $\frac{1}{2}$) of Lot Six (6), Block Four (4), Twin Cities Sub-Division, located in Southeast Quarter (SE $\frac{1}{4}$) of Section Six (6), Township Nineteen North (19), Range Twelve East (12), 147 $\frac{1}{2}$ feet x 205 feet,

through which is a flowing stream of water, running from the north towards the south, and,

Whereas, Shaffer Oil and Refining Company, and M. W. Thompson are the owners of a certain oil and gas mining lease, covering the lands above described, together with other lands surrounding the lots of the said Jennie May Cook and John R. Cook and are producing oil and gas therefrom; and in producing said oil and gas have permitted waste oil and salt water to flow from the premises so operated by them into said stream of water, flowing through the lot belonging to the said Jennie May Cook and John R. Cook, and,

WHEREAS, in the operation of such property by the said Shaffer Oil and Refining Company and M. W. Thompson it is impossible to prevent the pollution of said water to some degree, by reason of salt water and crude oil waste from the premises so operated by them into said stream, and,

WHEREAS, the said Jennie May Cook and John R. Cook are claiming some damage by reason of the flowage of salt water and crude oil in and along said stream and through the lot above described, owned by the said Jennie May Cook and John R. Cook, and the parties hereto desire to adjust any damage that may have been caused thereby.
