Beginning at a point on the South line of Lot 10, Block 16, Greenwood Addition, said point being 7.3 feet West of the Southeast corner of said Lot; thence in a Northerly direction a distance of 150 feet to a point on the North line of said lot, said point being 7.7 feet West of the Northeast corner of said lot.
