A strip of ground, not to exceed ten (10) feet in width on either side of the center line of said sewer line, as shown by the blue prints on file in the City Engineer's office of the City of Tulsa, the center line of said Twenty (20) foot strip, being more particularly described as follows, to-wit:

Beginning at a point on the West line of Lot 8, Block 13, Creenwood Addition, said point 64.65 feet South of the Northwest corner of said lot; thence running in a Northeasterly direction a distance of 76.93 feet to a point on the North line of said lot, said point being 8.3 feet West of the Northeast corner of said lot.
