Beginning at a point on the South line of Lot 18, Block 12, Greenwood Addition, said point being 24.5 feet East of the Southeast corner of said lot; thence in a Northeasterly direction a distance of 48.5 feet to a point on the East line of said lot, said point being 41.5 feet North of the Southeast corner of said lot.
