Beginning at a point on the West line of Lot 2, Centry Sub-Division, said point being 3.8 feet South of the Northwest corner of said lot; thence running Northeasterly 4.2 feet to a point on the North line of said lot, said point being 1.9 feet East of the Northwest corner of said lot.
