Beginning at a point on the South line of the West One-half of the Northwest Quarter of the Southeast Quarter of Section 30, Township 20-North, Range 13-East, said point being 330 feet East of the Southwest corner of said tract; thence running Northeasterly a distance of 265 feet to a point; thence at an angle of 84° 30' to the left a distance of 129.8 feet to a point on the South Right of Way line of the Atchison, Topeka, & Santa Fe Railroad. Beginning at a point where the above described line crosses the North Right of Way line of the Atchison, Topeka and Santa Fe Railroad; thence running Northwesterly a distance of 185.7 feet to a point; thence at an angle of 65° 5' to the right a distance of 919.5 feet to a point on the North line of said tract, said point being 25.58 feet west of the Northeast corner of said tract.
