Beginning at a point on the West line of Lot 5, Portland Place Addition to the city of Tulsa, Oklahoma, said point being 95 feet South of the Northwest corner of said lot; thence running Northeasterly a distance of 156.1 feet to a point on the Bast line of said lot, said point being 37 feet South of the Northeast corner of said lot.
